Vision & Mission

Vision

Values & Principles

Core Values



1. COMPASSION

We value the lives and dignity of all animals. We also understand that the systems that exploit animals and cause them to suffer are harmful to the human members of our communities.

2. IMPACT

Our work makes a difference in the lives of animals. We work to end all forms of animal suffering, but choose to focus our resources on tackling the worst forms of suffering that affect the most animals. We regularly examine and re-evaluate our progress and approach, and make evidence-based decisions about how to best effect legal, social, and corporate policy change for animals.

3. INCLUSIVE

We respect diversity, value equity, and strive for inclusivity. We believe everyone has a role to play in making legal, social, and corporate policy change for animals. We seek to break down barriers to ensure we welcome people from all communities into our organization and movement.

4. COLLABORATION

We seek out and work with allies to achieve results. Building a better world for animals is a complex undertaking, and we know that advancing this mission depends on building partnerships.

5. NIMBLE

We anticipate and react quickly to new opportunities and challenges. We support new ideas and technologies that have the promise of enhancing our work to help animals.

6. DETERMINED

We have the courage to persevere in the face of adversity. Transforming Canada's relationship with animals is a monumental task, and we are up to the job.

Guiding Principles

- **Animals are sentient**, with the ability to think, feel, and suffer.
- **Animals should not be mere property.** They deserve legal rights appropriate to their species, including legal standing.
- **Government, industries, and other institutions must be held accountable** for their role in causing animals to suffer.
- **Animals deserve laws to protect them, and public oversight.** Industries that use animals should not be allowed to self-regulate, or to operate without laws and oversight.
- **Transparency matters.** We believe people deserve to know the unfiltered truth about how animals are treated, free from industry spin and marketing.
- **Evidence matters.** We draw on scientific research, veterinary evidence, and the best available data to support our legal and policy work to help animals.
- **Protecting the rights of animal advocates** to speak up for animals is an important part of making social change.
- **Animal suffering and human suffering are deeply intertwined.** Building a better world for animals also benefits humans.
- **Reconciliation with Indigenous peoples** is a responsibility shared by all, including animal advocates.

LEGAL FOCUS



Animal Justice is Canada's only national organization focused on animal law advocacy. The law is one of our most powerful tools to make social change for animals, and Animal Justice is uniquely positioned to use it.

The Animals We Work to Help

Animal Justice fights for all animals in Canada across five animal issue areas.

1. FARMED ANIMALS

Factory farming causes unbearable suffering to hundreds of millions of animals in Canada every year.

Animal Justice's top priority from 2023 to 2025 is protecting farmed animals, because of their numbers and extent of suffering.

In 2022, over 841 million land animals were killed for food in Canada—a record high. An estimated 10 billion aquatic animals are also killed annually.


Farmed animals in Canada have virtually no on-farm legal protections during their lives. Most standard farm practices are exempt from animal welfare laws, and are still legal in Canada. This includes caging hens and confining mother pigs in gestation crates—practices widely condemned as some of the most cruel aspects of industrial farming, and banned in other developed nations.

Animal Justice is fighting for legal and corporate policy change for farmed animals.

Worryingly, US-style agricultural gag (or “ag gag”) laws arrived in Canada in 2019. These dangerous laws outlaw undercover investigations at farms and slaughter plants, and target animal advocates with massive fines and jail time. Farms and slaughter plants already operate behind closed doors, shielded from public scrutiny and legal accountability. Ag gag laws seek to shut down the only method the public has to learn the truth about what goes on behind farm doors: investigations by advocates and whistleblowers.

Animal Justice is actively challenging existing ag gag laws in court, and fighting to stop new ag gag bills from becoming law. Animal Justice also conducts and releases undercover investigations to expose widespread, hidden animal cruelty at farms and slaughterhouses.

2. COMPANION ANIMALS

Companion animals are beloved family members, and the law should treat them that way.

Most of us care deeply about the cats, dogs, and other companion animals with whom we share our homes. But the Canadian pet industry is almost entirely unregulated, leading to horrible suffering of the animals we love the most. Laws are weak, inconsistent, and poorly enforced. Puppy mills and backyard breeders run rampant in Canada, often with animals crammed into tiny, filthy cages, and forced to pump out litter after litter until their bodies give out. It's not just dogs who face this abuse—cats, rabbits, reptiles, birds, hamsters, mice, rats, and many exotic animals are also bred for sale. And while breeders profit from selling animals, animal shelters and rescues are stretched thin as they try to care for abandoned animals in need of homes.

Although many provinces restrict the ownership of some exotic animals, these laws don't go far enough. It's often still legal to keep wild and exotic animals as pets—no matter how much they suffer in captivity. Ontario, the largest province, has no restrictions whatsoever.

Companion animals deserve strong animal protection laws, backed by effective public enforcement to crack down on cruelty. Animal Justice is advocating to overhaul legal protections for the companion animals who depend on us.

3. ANIMALS IN LABORATORIES

Animals in laboratories deserve stronger legal protection.

At least 4 million animals like primates, dogs, birds, mice, and rats are used in research every year in Canada. They are often kept in barren conditions, and forced to endure cruel, painful laboratory experiments—sometimes without any pain relief. Unlike most other developed countries, the federal government doesn't regulate or oversee animal experimentation, and most provinces don't either. This leaves animals unprotected, and the public ignorant about the extent of animal suffering in laboratories.

In 2023, Canada passed a bill to end cosmetic testing on animals, and passed a groundbreaking bill aimed at phasing out toxicity testing on animals—the cruellest and most painful form of animal research. In toxicity tests, animals are subjected to practices like being force-fed deadly substances or having chemicals dripped into their eyes. More than 150,000 animals suffer in toxicity tests every year in Canada.

Canada now joins other countries worldwide that have passed laws to restrict or end animal toxicity and cosmetic testing.

Though these are positive and welcome steps, Canada still has a long way to go. We urgently need national regulation and oversight of laboratories, with regular, unannounced inspections and full public transparency. Canada should also create a national strategy and timeline to end animal experimentation as a whole, and instead mandate cruelty-free alternative methods that are better for animals, and are better science.

Animal Justice will continue to work to end the suffering of animals used for experiments, product testing, and teaching.

4. ANIMALS IN ENTERTAINMENT

Zoos, aquariums, and rodeos are harmful to animals.

Wild animals like elephants, lions, tigers, monkeys, whales, and dolphins belong in their spacious natural habitats—not caged for human entertainment. Zoos and aquariums condemn animals to a lifetime behind bars, often in isolation or social groups that are unsuited to them. They're condemned to live in cages or tanks that can never simulate their natural habitats or climates.

Animals used in rodeos and circuses are coerced into performing by fear-inducing, abusive training methods. Horses used in racing and rodeo

chuckwagon events have catastrophic injury and death rates. Causing distress to animals is illegal, yet rodeos are never prosecuted for cruelty.

Fortunately, Canada has been making some progress for animals used in entertainment. Most Canadians now oppose keeping animals in zoos and aquariums. Some municipalities have restricted circuses and zoos, horse-drawn carriages, rodeos, and other animal entertainment. And in 2019, Animal Justice was instrumental in passing a national ban on keeping whales and dolphins in tanks.

5. WILD ANIMALS

Wild animals lack basic protections.

Canada prides itself on our majestic and varied wildlife, but wild animals in Canada have few legal protections. They are subjected to trophy hunting, killing contests, trapping and snaring, fishing, poisoning, and government-sponsored extermination programs. In addition, fur farming is still legal in Canada, with animals like foxes, minks, and chinchillas confined in tiny, barren wire cages on industrial-scale fur farms.

Wild animals urgently need stronger protections, and it's time for Canada to join with other countries around the world that are closing down fur farms to protect animals, and prevent the spread of dangerous diseases.
