1) **did fail to comply to an Order, dated June 18, 2021 related to UCN#46186577 for three juvenile American black bears, issued pursuant to Sec. 30(1) of the Provincial Animal Welfare Act, 2019, S.O. 2019, c.13, as amended, thereby committing an offence under Sec. 49(1)(a)(ix) of the said Act.**

PARTICULARS: Fail to comply with paragraph 1 of the Order by not providing the three bears with an enclosure or, if the bears are housed individually, multiple enclosures, that meet the minimum dimensions, namely, 10,000 square feet to contain a maximum of three (3) bears, or 5,000 square feet to contain one (1) individual bear.

2) **MARINELAND OF CANADA INC. during the period beginning on or about September 11, 2021 and ending on or about February 18, 2022, at or near 7657 Portage Road, Niagara Falls, or elsewhere in the Province of Ontario, did fail to comply to an Order, dated June 18, 2021 related to UCN#46186577 for three juvenile American black bears, issued pursuant to Sec. 30(1) of the Provincial Animal Welfare Act, 2019, S.O. 2019, c.13, as amended, thereby committing an offence under Sec. 49(1)(a)(ix) of the said Act.**

PARTICULARS: Fail to comply with paragraph 5 of the Order by not providing the three bears, access to water sources such as pools, streams or ponds, that is permanent, and has an adequate filtration system to maintain institutional water quality parameters or is designed to allow easy draining, cleaning and refilling at suitable intervals to ensure water remains potable.

3) **MARINELAND OF CANADA INC. during the period beginning on or about September 11, 2021 and ending on or about February 18, 2022, at or near 7657 Portage Road, Niagara Falls, or elsewhere in the Province of Ontario, did fail to comply to an Order, dated June 18, 2021 related to UCN#46186577 for three juvenile American black bears, issued pursuant to Sec. 30(1) of the Provincial Animal Welfare Act, 2019, S.O. 2019, c.13, as amended, thereby committing an offence under Sec. 49(1)(a)(ix) of the said Act**
